GENERAL CONDITIONS*

PRICES

All prices are effective at the time of publication. However, these can be changed without prior notice considering the possible increases at our suppliers and imposition of new taxes.

Should such increase occur after confirmation of a reservation, client may cancel the commitment without paying any cancellation fees, providing the cancellation occurs within ten (10) days after receiving the change notice.

RESERVATION - DEPOSIT

A deposit of 50% of the total cost per person is required within ten (10) days of the reservation date.

The balance of the total amount of each fishing package is payable sixty (60) days prior to departure. Should the balance remain unpaid at the required date, MABEC LTD reserves the right to consider the trip as cancelled. Reservations made less than sixty (60) days prior to departure must be paid in full at the time of reservation.

CHANGES IN PACKAGES

Since reservations are usually confirmed several months in advance, some of the details are subject to change. However, these are generally minor changes with a minimal effect on the trip. Whenever possible, MABEC LTD attempts to provide with advance warning. In the case of major changes, MABEC LTD does everything in its power to offer a similar alternative package. Client can either accept or decline the new arrangements within ten (10) days following notice. In the latter case, MABEC LTD refunds all amounts paid. Such a refund is a complete and final settlement of any claim.

CANCELLATION - PACKAGE

In the event that MABEC LTÉE has to cancel a fishing package, every effort is made to provide an acceptable alternative. In the event of a refusal by the client, all amounts paid will be reimbursed.

CANCELLATION - TRIP

Any customer wishing to cancel their trip in whole or in part after confirmation must notify MABEC LTD immediately. A cancellation fee will then be charged as follows:

- the first 30% of the total amount of the package is not refundable;
- less than sixty (60) days before departure there is **no refund**; however, a substitute will be accepted at any time without any additional cost, except if an item of the package specifically applies to the person having reserved initially, which cannot be transferred (e.g., identified fishing permit).

No refund will be allowed by MABEC LTD for purchased services that are not used during the trip. Moreover the price or the value of the unused services cannot apply to other services.

FLIGHT SCHEDULES

All flight schedules are subject to change without notice.

INSURANCE

MABEC LTD strongly advises its clients to insure against risks generally associated with travel, both before and during the holidays, including the possible need to return before the scheduled date. This is particularly important with regard to medical and hospital costs.

RESPONSIBILITIES

The role of MABEC LTD is to provide outfitter services. However MABEC LTD must act as an intermediary between clients and organizations providing the required services (air transportation, hotel, etc.). Despite our best effort, we cannot exercise direct control over these organizations. MABEC LTD declines any responsibility for failure by them to provide the services described.

Without limiting the generality of the foregoing, MABEC LTD is furthermore not responsible for damages due to loss, damage, sickness, injury, delay, anxiety or inconvenience arising from:

- a) fault, negligence or omission on the part of the organizations offering the services (carriers, hotels, etc.);
- sickness, theft, strikes, mechanical breakdown, quarantine, weather conditions and all other conditions beyond our control;
- c) failure of the passenger to obtain and/ or carry required travel documents;
- d) passenger's late arrival at the airport, no matter what the cause, on the day of departure;
- e) loss of possessions, loss of goods and thefts;
- f) personal injury or death.

Furthermore, MABEC LTD is not responsible for additional costs that may result from the above. Clients must renounce all claims against MABEC LTD arising from the above conditions.

All contracts and transactions between MABEC LTÉE and the client are and will be deemed to have occurred and signed in Ste-Madeleine, Quebec, Canada, even if the trip has occurred or has been sold by a third party. Laws that apply to any transaction between client and MABEC LTD are those of the province of Quebec and the only court able to hear any dispute between the parties is the competent court in the judicial district of Saint-Hyacinthe.
